## Year in Review 2021/22

### Overview

- After the final round of lockdowns in July 2021, trading conditions have been slowly returning to normal for businesses in the Precinct and in general. However, new COVID strains and a major flu season in Winter 2022 have caused staffing difficulties for many businesses and kept a lid on turnover as well.
- City South has continued to provide support where possible, stay true to its goals and strategies and strengthen its ties to local Businesses and the Community during these trying times. Whilst they may not have been grand, we feel we've continued to make positive contributions to those around us over this last year.

# Strategic Planning

- Since 2015, CSA has utilised a Strategic Plan to guide its operations. The plan was formulated by the Management Committee and is updated and reviewed regularly to ensure adherence to the plan's listed fundamentals.
- The five Strategic Pillars that were identified in 2015 are still guiding our current goals and strategies. These pillars are: Business & Mainstreets Focus, Marketing & Events, Community Engagement, Art & Culture, and Safety & Environment Sustainability.
- In June 2022, the process of formulating the 2022-2023 Strategic Plan began and the document was completed in August 2022.
- Reviews of our progress were carried out at our bi-monthly Closed Committee Meetings.

# Mainstreets and Business Zones

- As part of CSA's strategic planning process in 2018, eight 'Business Zones' within the precinct were identified to help guide business support activities and provide a framework for reporting on business trends at the Lord Mayor's Precinct Forums.
- Whilst the Forum's format has changed and have no longer required us to report on trends, CSA has continued to monitor rental vacancies, business openings / closings and general changes in these zones throughout 2021-2022.
- The current status of these Business Zones are stated in our 2022/23 Strategic Plan.

## Zig Zag City South - Fri July 23 2021

- With a smaller budget allocated to this Zig Zag than previous July events, the focus moved from high profile live acts to programming smaller bands, acoustic duos and DJs across as many venues as possible. Running the event on a Friday night for the first time also meant that we were able to support a number of venues that host ongoing Friday night entertainment.
- Nine venues chose to be involved, acts were booked and promotion was done. Then, only four days out from the event, Adelaide was put into lockdown due to a Delta-variant COVID outbreak (with Precinct restaurant The Greek on Halifax one of the prime exposure sites).
- As such, the event was cancelled. However, determined to still realise the aim of supporting the artists and our local venues, the Committee decided to offer 50% cancellation fees to the performers, and \$250 Support Grants to the participating business to recognise their lost trade due to the lockdown. All the venues and artists were very appreciative of this gesture.


#### Whitmore Square Winter Lights - July 6 to Aug 9 2021

- Having not utilised the Festive Lights infrastructure for 2 years, as well as facing the prospect of no funding for the Association after the 2021 Financial Year, the Committee decided to organise one last installation of the lights on Whitmore Square. The timing of this would coincide with the inaugural Illuminate Adelaide Festival in late July / early August 2021.
- Thankfully funding for the next year has been approved, but the idea was still a good one. Approval from Council was sought and granted to do a month-long display of our colour-changing LED Festoon lights and large green floods to add some colour to our Precinct, given that no official Illuminate events were occurring in our area.
- The lights were installed on Tues July 6 and remained in place until Aug 9.

## Festive Season Shindig - Thu Nov 25 2021 with Brasil Nuts Orchestra at The Astor Hotel Balcony

 After a successful sold-out show last year, City South hosted another Christmas live music event on the balcony at the Astor Hotel, this time with popular trio Brasil Nuts Orchestra playing quirky covers and latin grooves to an appreciative crowd of around 50. On a lovely mild evening, the Balcony was the perfect place to enjoy some great tunes, suprb catering from the venue and the good company of locals and Councillors.

## Yarn Bomb Christmas Tree - Dec 2021

 This Christmas both of our unique Yarn Bomb Xmas Trees were displayed in the Minor Works Community Centre for the month of December. This time around, the trees were not positioned in a place that was viewable from outside, so the solar powered LED lights used to highlight them at night were not used. However we still received many positive comments on them





## Year in Review 2021/22 - Projects

#### Autumn Cheers Gift Voucher Program - May 16-29

- After successful Coffee Shout and Christmas Cheers Voucher programs, City South offer another round of Gift Vouchers to Members and Mailing List recipients in mid-May 2022. \$20 vouchers were distributed to Members and \$10 vouchers were distributed to people on our Mailing Lists for redemption during a 2 week period at local venues Seoul Sisters and 55ML
- Encouragingly, redemption rates were much higher for Mailing List recipients with just as many Vouchers redeemed by these recipients as Members.





### Year in Review 2021/22

#### **Open & Closed Meetings**

- CSA's committee members meet every second month in a Closed Meeting format (elected committee members only) to work through current projects, share updates from Council and review our goals and strategies.
- In the alternate months, CSA had been hosting informal Patch Catch Up gatherings where all stakeholders in our Precinct are welcome to attend to discuss ideas and issues. Catch Ups were held in local hospitality venues in November, April and June 2021.
- The Annual General Meeting was held on Wed Sept 8 2021 at Rob Roy Hotel with a very good turnout of over 25 including five City Councillors.

### Year in Review 2021/22

#### Membership & Committee

- While Business Membership growth has remained slow, Resident and Pensioner Membership has continued strong growth to its highest ever level in its 15-year history.
- After a year as President, Keiran Snape moved on to become an Area Councillor with the City of Adelaide. Briony Hunt became the new President at the AGM. Long-time secretary and public officer Bri-Anne Keen continued on her role, as did the rest of the Committee Members from 2020-21.

### Year in Review 2021/22

#### Networking with Community Groups

- CSA continued to support the projects associated with the South West Community Centre and the South West City Community Association by helping to promote their events through our newsletter and social media.
- CSA is committed to engaging with local community groups as much as possible, and encourages local groups to attend our Patch Catch Up gatherings.


### Newsletter, Website & Social Media
